

Cynthia provided information about the upcoming 30th Birthday Celebration and Annual General Meeting to be held on the 6th October 2017 at the City of Whitehorse Nunawading premises (Willis Room). Copies of the flyer, CCOEI Membership Forms and Committee of Management Nomination Forms circulated. Cynthia noted that there would be a speaker from the Australian-Iranian Society of Victoria, Mr. Bahram Monshat, and also a cultural music performance. The focus of this event is the Iranian community, their culture, their settlement needs and success stories. This event was planned last year as part of the MSC Calendar.

Behaviours included some women at first refusing to wear a scarf. Some inappropriate questions were asked, however the host answered in a very respectful manner. One of the mosques provided a very elaborate meal. The hosts seemed to win over their guests (most were keen to learn). Behaviour changed for the better as the day progressed.

Helen said that as part of their research they would like to speak to people running/hosting other similar events. There was a feeling that not enough work was being done with Australian residents to help them to be more accepting of different groups.



(ii) Population, Migration and Social Inclusion focus program

Rebecca provided a brief overview of the program and a link to the Survey https://www.accsvic.com/
People from CALD backgrounds were encouraged to participate in the online survey. To assist them the survey has been translated in the top 5 languages. The survey asks questions like: what is it like to live in your local community? Findings from the survey will be used to improve the quality of social cohesion in Melbourne communities.

Forums update

- (a) Family Violence Forum 2017 (Cynthia Shaw). Forum on 19/09. Forum program being finalised.
- (b) Health Forum 2017 FGM/C and Forced Marriage forum. (Cynthia Shaw) held on 11/08, well attended, feedback very positive. Forum report being written and will be launched on the 06/10 at CCOEI 30th Birthday celebrations and AGM. The report will be launched by Inga Peulich.
- (c) Employment Training and Community Engagement Forum 2017 "My Choice, My Life" (Bwe Thay) Scheduled for 26/10, with the working group regularly meeting; many organisations participating.

Organisations update

- (b) **MIC (Saturnino Onyala)** Update included settlement referrals from AMES, new arrivals are mainly from Syria, Iraq and Myanmar;
- (c) **Centrelink DHS (Dianne Godfrey)** Support recipients of services to access services on line continues. More information on services www.humanservices.gov.au/
- (d) Victoria Police (Liz Sidiropoulos and Johnny Tran) VicPol continues its community engagement work in various councils in the east, including Manningham and Monash, e.g. Burmese new arrivals and fire safety (Manningham), and safety outdoors; family violence forum;
- (e) DSS (Dusko Gjurcinovski) provided information on DSS case management framework the service is outcomes focused;
- **(f) Swinburne University (Bwe Thay)** Transition to Higher Education and awareness of what is possible posters circulated. Two buses have been organised to take students to city campus (Docklands);
- (g) Women's Friendship Group (Helen Jurcevic) Visit to Cambodia and Medical equipment to Cambodia. Helen provided information on her visit to Cambodia great photographs and stories. "Cambodia is still recovering from the Khmer Rouge's brief but destructive reign between 1975 and 1979. Somewhere between 1 and 3 million people (one in four Cambodians) were killed under the regime, and the country's economy and social structures were devastated". Unexploded ordinances are still a very big danger for Cambodians especially in rural regions. "Past conflicts have also contributed to high rates of disability in the Cambodian population: around one in five disabilities in Cambodia is the result of war or injury from landmines and other unexploded munitions" 100s of Kgs of donated goods medical supplies, clothing, and health products have been sent to Cambodia to assist children, particularly girls, affected by landmines (the Centre in Battumbung is funded by Caritas).
